



National Credit Regulator

The National Credit Regulator (NCR) was established as the regulator under the National Credit Act 34 of 2005 (the Act) and is responsible for the regulation of the South African credit industry. It is tasked with carrying out education, research, policy development, registration of industry participants, i.e. credit providers, credit bureaux and debt counsellors, investigation of complaints, and enforcement of the Act. The Act requires the Regulator to promote the development of an accessible credit market, particularly to address the needs of historically disadvantaged persons, low income persons, and remote, isolated or low density communities. The NCR invites applications from suitable candidates for the following position:

Legal Advisor (Complaints)

Paterson Grade: D - Lower

Requirements:

- The successful candidate must hold a relevant Legal Degree (BProc and/or LLB) and a minimum of 3 years post admission experience as an Attorney or Advocate working in a litigation environment.

Duties:

- Effectively dealing with general and debt counselling complaints in accordance with the National Credit Act.
- Reviewing and investigating complaints.
- The provision of legal advice on specific issues related to the National Credit Act and other related legislation.
- Conduct external communications and presentations related to the NCA.
- Attend meetings with external parties on behalf of the department.
- Develop and draft agreements, memorandum and legal briefs on behalf of the department and the NCR as and when required.
- Liaise with Ombudsman, Provincial Consumer Affairs Offices and other relevant stakeholders.
- Research into issues and topics relevant to the NCR within the credit market.
- Assess and evaluate written enquiries.
- Provide training to internal staff on the NCA, court decisions and related pieces of legislation.

Knowledge:

- Knowledge of the National Credit Act.
- Understanding of the South African Credit Market.
- Legal/court procedures.
- Complaints resolution processes.

Skills:

- Drafting and advocacy skills.
- Excellent communication skills (written and verbal).
- Conflict resolution skills.
- Strong personal and professional ethics.
