## **SPECIFICATION**

**Terms of reference for the appointment of an accredited service provider to conduct a 10-year pressure test on ten CO2 extinguishers, supply and install bracket for a CO2 fire extinguisher and replace the hose.**

### **1. Purpose**

The NCR would like to appoint an accredited service provider to conduct a 10-year pressure test on ten CO2 extinguishers, supply and install bracket for a CO2 fire extinguisher and replace the hose.

### **2. Scope of work**

2.1 The ten (10) CO2 Fire extinguishers 10-year pressure testing as per SANS 1825

2.2 A CO2 Extinguisher no. 26 inside Procurement storeroom, hose perished and needs replacement.

2.3 A CO2 Extinguisher no. 26 to be repositioned as per standard. The bracket must be moved.

### **3. Pre-requisites**

3.1 The bidder must submit proof of accreditation with the South African National Accreditation System (SANAS).

3.2 The service provider must have attended a compulsory site visit. The site visit is scheduled for **18 March 2025 @ 14h00.**

3.3 The Bidder must submit a letter from the Department of Labour (COIDA). The bidder must ensure compliance to the Occupational, Health and Safety Act 85 of 1993 for the duration of contract.

3.4 The bidder must, at his own expense, take out sufficient insurance against any claims, costs, loss and or damage ensuing from its obligation and shall

ensure that such insurance remains operative for the duration of this work. A copy of insurance must be submitted as proof.
